
# **CHARLES M. DUNN, II** Vice President of Claims and COO Retires After 39 Years with MACM











Over the years, Chuck has worked with physicians, defense counsel, and fellow employees to protect Mississippi physicians.

ON SEPTEMBER 26, 1979, CHUCK ATTENDED HIS FIRST MACM BOARD OF DIRECTORS MEETING. SINCE THEN, HE HAS ATTENDED 158 MEETINGS, ONLY MISSING TWO IN 39 YEARS.

UNDER CHUCK'S LEADERSHIP, OVER \$500 MILLION IN INDEMNITY AND EXPENSE HAS BEEN SPENT THROUGH THE CLAIMS DEPARTMENT TO PROTECT INSURED PHYSICIANS.

THE FIRST CLAIM FILE ASSIGNED TO CHUCK WAS #75. CURRENTLY, THERE ARE OVER 21,000 CLAIMS FILES SET UP BY THE MACM CLAIMS DEPARTMENT.

On August 1, 2018, MACM Vice President of Claims and Chief Operating Officer Charles M. "Chuck" Dunn, III, will retire after 39 years working to protect Mississippi physicians. As the third employee hired, he has watched MACM grow from a startup company to the organization it is today, with almost \$335 million in assets and a surplus of \$260 million.

In 1979, Dunn was working as a Claims Supervisor in the Jackson office of Western Casualty and Surety when he received a phone call that would forever change his life. Former MACM President and CEO Mike Houpt had met Dunn through the Mississippi Claims Association and reached out to see if he was interested in working for and helping to grow a very young medical professional liability company. This company was the Mississippi Medical Fraternal and Educational Society, the predecessor to today's Medical Assurance Company of Mississippi (MACM).

Houpt convinced Dunn to meet for an interview with R. Faser Triplett, MD, an allergist in Jackson that was instrumental in the creation of the company.

Over lunch at Primos across from the Mississippi Baptist Hospital, Dr. Triplett described to Dunn the business plan, goals, and structure for this new company - one that would be owned and governed by Mississippi physicians. Based on this conversation with Houpt and Dr. Triplett, the likelihood for success was strong, the nature of the work was interesting and unlike what he was doing, and the opportunity to be involved from the beginning was too good to pass, so the young claims adjuster took a chance and started work as Assistant General Manager on July 9, 1979.

"We had the ability to really expand the book of business in Mississippi for professional liability," Dunn said. "As we would go visit with prospects, Dr. Triplett would convince them to come with a home-grown company, and we rapidly became the predominant carrier in Mississippi."

Prior to coming to MACM, Dunn had limited experience with medical malpractice claims and quickly learned the benefits and different types of coverage options as he and others marketed the company to prospects. At the time, most professional liability coverage was written as an occurrence policy, but other physician-owned carriers across the country were switching to a claimsmade policy, and the MACM management believed this was a stronger product for physicians.

"We spent a lot of time convincing physicians to join the company and then we had to convince them to try a totally different coverage type. They thought we were crazy," Dunn said. "There were a lot of physicians that took a chance on a young company and staff, and I am forever grateful that they did. Those visionary founders made immeasurable contributions to the success and growth of MACM. Most have retired, died, or moved on to other opportunities, and they are greatly missed."

In addition to new coverage options, different people to work with each day, and an expanding customer base, one of Dunn's first priorities was establishing relationships with defense counsel throughout Mississippi that were knowledgeable about medicine and professional liability. He searched out attorneys in Mississippi who understood how to defend and communicate with physicians. At the same time, Dunn had to learn medical terminology and information himself in order to communicate with physician insureds and advise on the defense of claims.

Working with these defense counsel that specialize in medical malpractice has been one of the greatest enjoyments, and sometimes sources of entertainment, for Dunn as he has seen a little bit of everything in the trial process over the years.

During a trial early in the company's history, Dunn, along with the defense counsel, was in a room inside of a local courthouse in Mississippi when a huge racket was heard. The husband of the plaintiff went berserk and attacked two deputies and the local district attorney inside the courtroom. As Dunn ran down the hall and rushed back to the courtroom, he could hear and see the plaintiff's husband turning over tables and throwing paper files everywhere. The presiding judge hurried into the courtroom and punched the husband in the nose, knocking him to the ground, where the two deputies could subdue him. The case against the MACM insured was eventually dismissed.

"At the time, all I could think was ... what have I gotten myself into?" Dunn said.

Another early case found a plaintiff upset with the two defendant physicians to the point that large handmade (and very disparaging) signs were displayed along the local roads and in the hallways of the hospital. The signs continued to appear in spite of a court ordered injunction to cease and desist the sign making. When the plaintiff was caught putting up another sign in the hospital's hallway, the judge ordered incarceration until the plaintiff agreed to stop. The plaintiff refused and spent weeks in the local jail. "Everyone was a little afraid of that person," Dunn explained with a laugh.

As Dunn moves into the sunset of his career, he leaves behind a strong team to continue defending Mississippi physicians. On August 1, 2018, Todd Savell will become Vice President of Claims, and Keith Westbrook will assume the title of Claims Manager, both having worked with hundreds of physicians and clinics through the years representing thousands of cases.

"This next level of management has years of experience working with Mississippi physicians," Dunn said. "They are knowledgeable, talented, and wonderful people in the MACM Claims Department. I look forward to watching their work from afar."
